## VICTIM'S STATEMENT:

On 08/21/08, Probation Officer Diane Adams interviewed the victim, Ms. Helen Woichowski, in Room 220 at the Heron East facility located at 2290 Cattlemen Road, Sarasota, Florida.

Upon this probation officer's arrival at Room 220 at approximately 11:20 a.m., Ms. Woichowski was out of bed and was walking to or from the adjacent bathroom when the aide opened the door to her room. This probation officer told the victim that this probation officer was there to take a statement from her and to inform the Judge of anything the victim wanted the Judge to know. The victim began by stating, "Tomorrow they are having the trial." She stated that she learned this from her daughter in Kansas and said that she calls her daughter from her room every day, because her daughter is not allowed to call her. She further stated that her daughter is not allowed to call her because, "They say I need protection and my daughter is upsetting me."

Ms. Woichowski stated that this has been going on for two and a half years and said it is driving her crazy. She stated that she had a stroke and her granddaughter had a husband who wasn't giving anything toward the household bills. She stated that she told her granddaughter that if she did not get rid of the house that they were going to lose it. Ms. Woichowski stated that this was all because of her granddaughter's ex-husband, and she said that after her granddaughter threw him out, he came to the residence one morning and called the police. The police came and asked Ms. Woichowski some questions and then told her to throw the bum out. She stated that the ex-husband called her, Ms. Woichowski, for two weeks, trying to be nice, and she did not know until later that he was beating up her granddaughter all along, because her granddaughter kept this from Ms. Woichowski. Later she stated that in four years, her granddaughter's ex-husband gave her cash only twice, \$240 once and \$300 the other time. Later, she stated, "He was a painter and he didn't give nothing to keep a house going." She said he was to do work on her house, painting and laying wooden floors, and he did not finish the work and Dana had to pay someone else to do the work. She also stated that he was abusive to her grandson as well, and said she saw her granddaughter defending her grandson from him one time, and she stated, "He would have killed that kid; he's got an awful temper."

Ms. Woichowski stated that her granddaughter has been with her since she was a teenager and stated, "We are family." When asked, Ms. Woichowski stated that she knew all about refinancing the house, and later in the conversation, she stated, "She went through hell and nobody realized it...they say she took my money. If I was giving it to her, what business is it of theirs? If I'm not going to need it much longer, why can't I give it to her?" Ms. Woichowski spoke of working all her life and about bringing up her daughter without her husband, whom she divorced. She stated she never got any [child] support from him. She said that she managed to buy a house and finished paying for it. Ms. Woichowski then started to cry and said that friends call her and she isn't told that they call. She stated, "They won't tell - they are holding me hostage. I would rather live alone with my family."

Ms. Woichowski stated she wrote a letter to the Judge, and also said that she informed someone that she wanted a ride there (to Court) during the trial to testify.

Regarding the sentencing on 08/22/08, Ms. Woichowski stated, "In one way, I want to go, and in another way, I don't want to see what happens." Ms. Woichowski started to cry again and said, "Because that girl has been good to me and now it seems like she is losing everything." She then stated, "If someone had told me this would happen, I never would have come here. I had it good at home."
